Well this will be the last article I write as your Aerie President. I would like to wish your New President John LeBouton and his officers good luck in the upcoming year. They we need it trying to get people to be active.

The concession stand at Spanbauer Memorial Field is going fairly well. We do have tournaments out there June 18th, 19th and 26th. If anyone would like to help during these days, please contact me ASAP with what days you are available.

The Larry Dunn Memorial Tournament ended May 15th with 61 male entries and 27 women entries for a total of 88 entries. Of the 88 entries 12 people bowled more than once making up 29 of those entries, which means we only had 59 other bowlers. Sadder yet, of those 71 total bowlers only 10 aerie members which only 5 were officers bowled and 6 auxiliary members and only 4 were officers. We took 11 men's teams and 2 women's teams to State Eagle's all the way to Marshfield. Only 9 of 44 men that went bowled and 6 of the 8 women who went bowled in our local tourney. I know I'm spouting out, but let me put it to you this way: This tournament is one of our Charity Fund Raisers and \$5.00 from each entry goes towards cancer research!. I would believe each and everyone of you have been affected by losing someone to cancer, so if that isn't enough to make you want to participate in a fundraiser for cancer research, I'm sure my preaching won't either. Starting from next bowling season I will keep you informed of the squads and leave it at that. The tournament runs 7 months, so everyone should have plenty of time to put a squad together. Many thanks to those that did bowl. On a good note, I would like to thank Chuck Anderson form Andy's Pub and Grub who bowled and donated 3-\$10.00 gift certificates he participated in. Also to Mike Mugerauer (non-member) who donated \$20.00 the cost of an entry which all went to cancer research.
